#### Stewardship Group

Since its start in Fall 2019, the Harper Park Stewardship Group has logged 16.5 hours! The group has been working hard on removing invasive species (such as English ivy), planting native species, and getting folks out to the park. In February 2020, the group planted more than 40 native plants, shrubs, and trees – such as Oceanspray, Vine Maple, and Western Red Cedar.

## **Trail Maintenance**

Volunteers are diligently working to maintain and improve trails at Harper so that the park is accessible for all to enjoy – an impressive total of 56.5 hours of service!

YouthBuild logged 40.5 hours, over two days in August and September 2019, focused on trail maintenance on the Harper Hill Trail.

Youth Mountaineers logged 16 hours in the park in December 2019, learning about native plant species and Harper's history, as well as performing trail maintenance.

### **Interpretive Signs & Displays**

The effort to bring outdoor interpretive signs and displays to Harper Park began in March 2020. An initial community survey informed the development of these signs and displays. Survey questions asked community members what interpretive themes and topics they would like to see represented in Harper. Responses included estuary information, plants and animals, brick factory, Tribal camps and villages, hiking trails, and information for boaters and kayakers. View the survey results <u>here</u>.




### **Park Improvement Plan – Final**
